When the vessel is operating on a Limited Coastwise voyage (not more than 20 miles from a harbor of safe refuge), the number of passengers may be increased to 82. A life preserver shall be provided for each person on board.

If the vessel is away from the dock, or passengers are on board or have access to the vessel for more than 12 hours in any 24 hour period, an alternate crew shall be provided and the number of passengers shall be decreased accordingly so that the total persons on

- (f) If vessel is greater than 15 gross tons, freight may not be carried for hire.
